Influential and affluent citizen of county, and at one time owned about two thousand acres of land in the Chehalem Valley. He was a Democrat of the Jacksonian type and served in one or more sessions of the state legislature. He was one of those who founded the agricultural college at Corvallis which later became Oregon State College. Active promoter of woolen mills in Oregon City. A member of the Methodist Episcopal (South) Church.

'The Hon. J. L. Ferguson died at his home in Lafayette, OR at the age of 71. native. He located in Lafayette and engaged in the harness and saddlery business. For about twelve years he lived on a farm in the Chehalem Valley, during which time a horse that he was riding fell on him inflicting a permanent injury. He returned to Lafayette slightly before 1880. Mr. Ferguson was twice a member of the Oregon legislature being a democrat of the Jackson type. He had strong convictions and the courage to express them. The cause of death was paralysis''.
